A MESSAGE FROM THE CLERK OF COURTS

Pursuant to O.R.C. 1901.14(A)(4), the 2020 Annual Report for the Stow Municipal Court is attached. The Stow Municipal Court serves 16 communities, consisting of 7 cities, 5 villages and 4 townships. This Report is provided to each community and reflects not only jurisdiction-wide totals of the Court's total 2020 case load numbers, revenues and distributions, but also includes a breakdown of these statistics by each community as well.

Overall the revenue receipts for 2020 decreased by \$1,086,134 or 14.8% from the receipts for 2019. This unprecedented decline is directly attributable to the decrease in caseload and assessments caused by the worldwide Coronavirus 19 pandemic. While revenues only decreased by 14.8%, total caseloads decreased by 5,766 or 28% when compared to 2019. The Court's traffic docket was the hardest hit, with 3,040 or 31.5% fewer cases filed in 2020 compared to 2019. In total, the Court processed 14,916 cases (3,123 Civil, 11,793 Criminal/Traffic). However, despite the challenges presented by the pandemic, the Court was still able to cover its annual operating deficit without billing any of the 16 communities served by the Court.

Below are some of the highlights of 2020:

- Unlike many of the Courts throughout Ohio, both the Stow Court and the Stow Clerk of Courts remained fully operational throughout the entire pandemic. Accommodations and safety precautions were enacted by both offices to keep the patrons served by the Court and the employees reporting to work safe. This includes successfully accommodating three jury trials in 2020.
- Thanks to the Ohio Supreme Court, the Court and the Clerk jointly received \$21,640.89 in Coronavirus technology grants in 2020. The grants paved the way for both the Court and the Clerk to modernize their operations by utilizing zoom or skype software for routine court appearances, purchasing equipment to enable more employees to work remotely, and upgrading jail technology to increase the Court's use of video appearances during arraignment.
- The Clerk of Courts Office also enjoyed a record breaking collection rate of 96% in 2020, mitigating the potential loss of revenue due to the Coronavirus by half (14.8% total decrease in revenues compared to 30.8% decrease in assessments). The 18% increase in the Clerk's collection rate is attributable to a number of factors including changes to clerk collection practices in 2020, the normal lag in the debt-life cycle for criminal/traffic cases (defendants may take 6-12 months to pay off a case), and the wide distribution of federal stimulus monies in 2020. The Clerk's Office also continues to use the Ohio Attorney General to aid in the collection of delinquent fines and costs. This free service allows the Clerk's Office to seize a delinquent debtor's state income tax refund to offset their unpaid fines and costs. Since 2016, the Clerk's Office has received over \$2.5 million in debt collection from its partnership with the Ohio Attorney General.
- The Court continues to operate its Mental Health Court STRIDE (Successful Treatment Results in Developing Excellence) with Judge Lisa Coates serving as the Presiding Judge of program. Since its inception in 2010, STRIDE has had 80 participants, 35 successful graduates, and currently has 9 pending participants in this 24-month treatment program for offenders convicted of crimes as a direct result of mental illness. The STRIDE Court also receives over \$50,000 annually in the form of grants to fund the specialized docket.

On behalf of our Judges, Lisa Coates and Kim Hoover, along with myself and all of our dedicated staff at the Stow Municipal Court, we look forward to 2021 and remain focused on continuing to provide you with the highest level of professionalism and customer service.

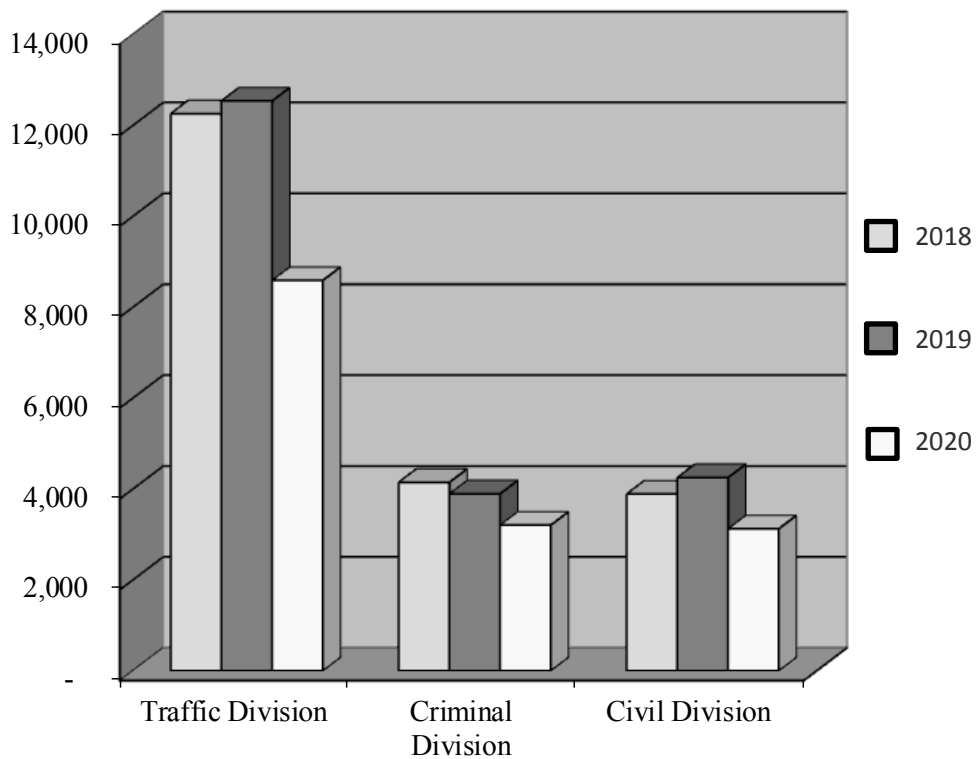

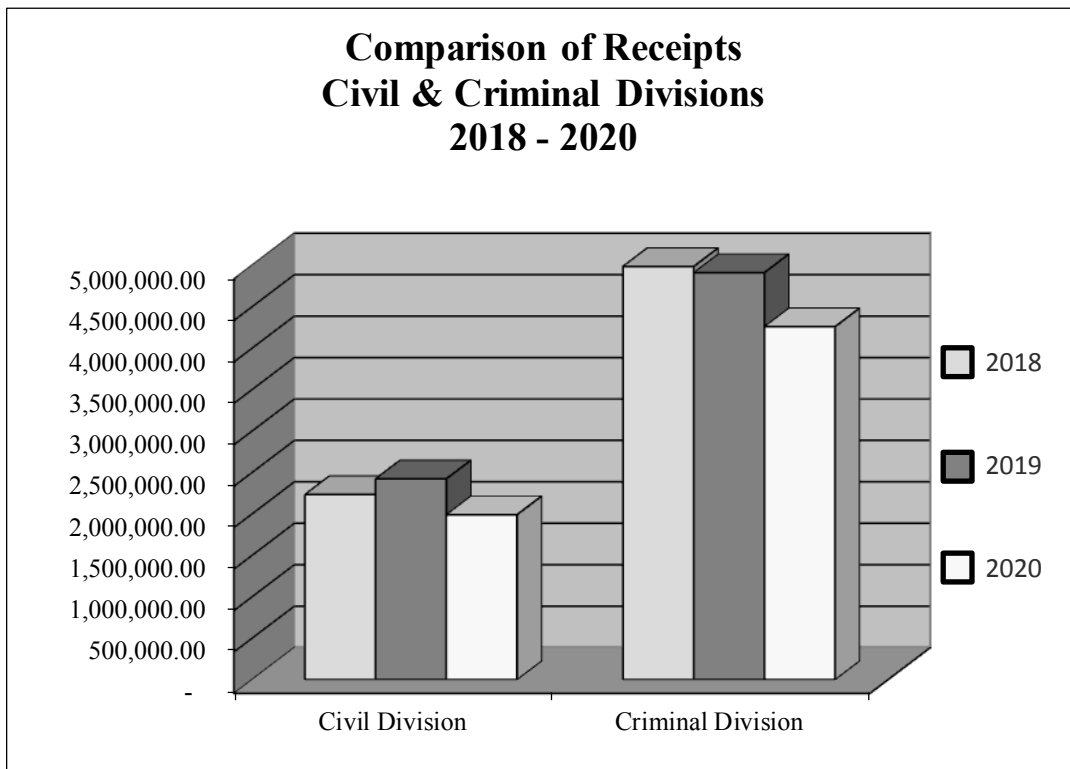
**Case Load Comparison

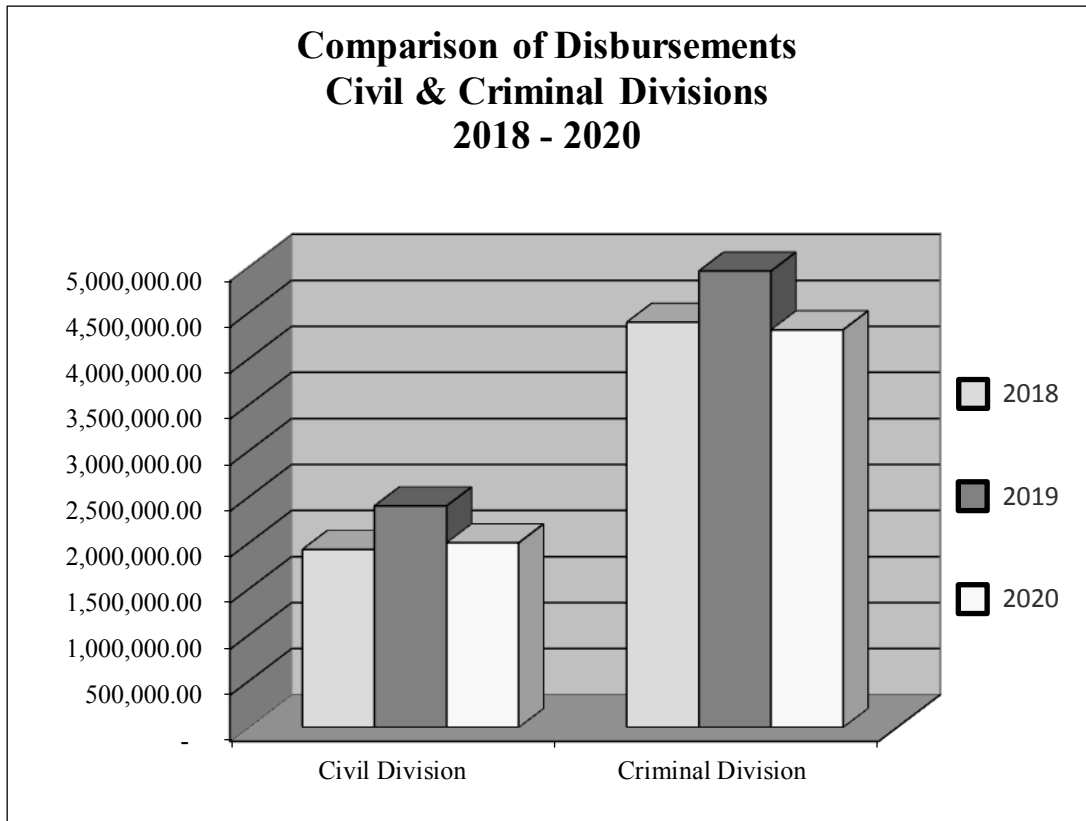
