The following is intended to provide basic information about the process to seal or expunge records related to cases in the Stow Municipal Court. If you need additional information or if you have legal questions, you should contact an attorney. Ohio law on sealing and expunging cases can be found in Ohio Revised Code, Section 2953.

APPLICATION PROCESS:

- 1. Verify that you have no open cases or active warrants in any courts, all fines have been paid, and all court orders have been completed.
- 2. Refer to the following information to determine if your case(s) is eligible for sealing and/or expungement.
- 3. Complete the Stow Municipal Court's <u>Application to Seal or Expunge Records</u> and submit it to the Clerk of Court's Office with the \$100 application fee or affidavit of indigency.
- 4. Once an application is filed, it will be forwarded to the Community Control Department to conduct a background investigation and eligibility and if you have been satisfactorily rehabilitated before making a recommendation to the judge or magistrate.
- 5. If necessary, an oral hearing will be scheduled in no less than 45 days and no more than 90 days from the date the application is filed.

WHAT OFFENSES ARE <u>NOT ELIGIBLE</u> TO BE SEALED OR EXPUNGED:

- Traffic convictions
- Domestic Violence convictions (4th degree misdemeanor is allowed)
- Violating Protection Order convictions
- Offenses in which the victim of the offense was less than 13 years old (does not apply to nonsupport of dependents)
- Sexually oriented offenses when the applicant is subject to the requirements of ORC Chapter 2950 (sex offender registry)
- Felony offenses of violence that are not sexually oriented offenses
- A 3rd degree felony if applicant has exactly two 3rd degree felonies + two misdemeanors + any other convictions
- A 3rd degree felony if applicant has two or more felonies of any degree
- 1st or 2nd degree felonies

Final Discharge. A case is discharged when a person has fully completed any jail or prison sentence, any terms of community control, probation or parole, all payments of fines or fees that were a penalty of the conviction, all driver's license suspensions have ended and all orders to "Obey All Laws" for a specified period has expired.

Sealing Records: If a court grants an application to seal the record of case(s), it is removed from public view at the court and all related public agencies. Further, and the conviction cannot be used to exclude someone from employment or housing opportunities (except for state licensing boards – i.e. nursing, childcare, and law enforcement).

Expunging Records: If a court orders a record expunged, it is physically destroyed as if it never happened.
