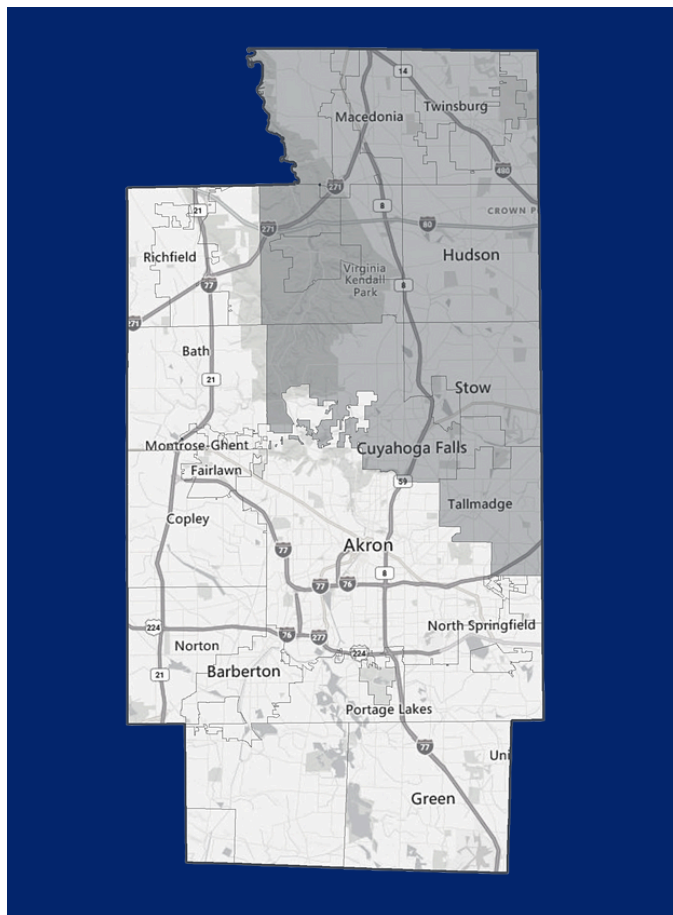
Located off of Route 8 and Steels Corners Road in Stow, Ohio, the Stow Municipal Court was established in 2009. The Court was originally located in Cuyahoga Falls, Ohio and was the first municipal court to move to a new host city in Ohio's history. The Court elects two municipal Judges and one Clerk of Court, each for six year terms.

Summit County, Ohio

The Stow Municipal Court serves the residents of the following 16 communities in northern Summit County:

City of Cuyahoga Falls, City of Hudson, City of Macedonia, City of Munroe Falls, City of Reminderville, City of Stow, City of Tallmadge, City of Twinsburg, Village of Boston Heights, Village of Northfield, Village of Peninsula, Village of Silver Lake, Boston Township, Northfield Center Township, Sagamore Hills Township, Twinsburg Township.

The jurisdiction of the Court includes traffic, criminal, and civil cases. The Court hears misdemeanor criminal and traffic cases, with felony cases initially arraigned in the court and then bound over to the Common Pleas Court. Civil cases involving contested dollar amounts not exceeding \$15,000 are heard in the Court, as are eviction cases and small claims cases up to \$6,000.



MEET JUDGE LISA COATES

Judge Lisa Coates was appointed to the Municipal Court in March 2003 and elected to a six-year term in November 2003. She was re-elected in 2009, 2015, and 2021 and is currently serving her fourth term.

She received her Bachelor of Science in Business Administration from Bowling Green State University. Following graduation, Judge Coates pursued a law degree at Case Western Reserve School of Law.



Upon graduation and admission to the Ohio Bar, Judge Coates was employed with the Federal Government. She began at the Department of Veteran Affairs and then transferred to the Social Security Administration. After a short time at a civil law firm, she started as an Assistant Summit County Prosecutor in the Criminal Division. She then became the judicial attorney for a judge at the Summit County Court of Common Pleas.

Since being on the bench, Judge Coates played an integral part of establishing the court's underage alcohol diversion program. She also established the court's first specialized court, a mental health court known as STRIDE (Successful Treatment Results In Developing Excellence). STRIDE received its initial certification from the Ohio Supreme Court in December 2013.

Judge Coates is a member of the Ohio State Bar Association, Akron Bar Association, Cuyahoga Falls Rotary and Cuyahoga Falls and Stow Munroe Falls Chamber of Commerce. She is also part of the judicial mentorship program established by the Ohio Supreme Court and has served on the Summit County Criminal Justice Advisory Board.

MEET CLERK AMBER ZIBRITOSKY

Amber Zibritosky was first appointed Clerk of Courts in March 2019, and later elected to a partial term in November 2019. She was re-elected to a full six year term in November of 2021. Clerk Zibritosky serves as the keeper of all official records and the fiscal manager for all fines and fees collected and disbursed by the Court.



Clerk Zibritosky is also an attorney, licensed to practice law in the State of Ohio since 2010. She received her Juris Doctorate from the Ohio State University in the same year and her bachelor's in Political Science from Miami University. Prior to becoming Clerk, Amber served as Stow's elected Law Director, and Chief Prosecutor for 5 of the 16 jurisdictions that comprise the Stow Municipal Court district and oversaw the prosecution of thousands of cases per year.

Since taking office, Clerk Zibritosky has worked to modernize the Court. Her office offers a completely paperless filing system for all civil filers and online public access for criminal and traffic records. The Court now also uses text message notification for court appearances and accepts e-ticket filings for nearly all traffic cases. Amber believes everyone should have access to justice. In 2021, Amber published self-help materials in plain English on the Court's website for self-represented filers.

Clerk Zibritosky is a current member of the Ohio Association of Municipal / County Clerks of Courts (OAMCCC) and the Chair of the Akron Bar Association's Access to Justice Committee. She also serves on the Facilities Governing Board of Summit County and on the Oriana House Advisory Board. Amber is certified in Lean Government Management and is currently working towards her Certified Court Manager (CCM) accreditation from the Ohio Supreme Court.

STRIDE COURT

Judge Lisa Coates serves as the presiding Judge for the Court's specialized mental health court docket called STRIDE (Successful Treatment Results In Developing Excellence). Established in 2010 and re-certified by the Ohio Supreme Court four times since, STRIDE is an 18-month intensive program where the program participant attends court on a regular basis.

The goal of STRIDE is to reduce recidivism and periods of incarceration among individuals with severe and persistent mental illness by providing judicial supervision over mental health interventions that are integrated with community treatment options.

Since 2010 the STRIDE Court has accepted nearly 100 participants into the program. The specialized docket receives a subsidy to cover STRIDE staff salaries as well as to provide necessary treatment services for qualifying participants.



CLERK PROJECTS

Strides in Technology: The Clerk of Courts took significant steps to modernize the Courthouse in 2024. The Court continued to implement e-ticketing with new jurisdictions and also moved to electronic storage of all closed criminal and traffic cases going forward.

Traffic Camera Citations: The Court enacted Local Rule 40 in 2024 to accept traffic camera cases from Peninsula Village and Boston Township. To meet the volume of this new caseload, the Clerk of Courts Office developed internal software to import the tickets electronically without hiring additional staff. From July 1st to December 31st, the Court accepted 6,928 traffic camera filings and the Clerk collected over \$170,000 in court costs that were directly applied to offset the Court's operating costs.

Collection Rate Growth: The Clerk's Office overall collection rate improved by 5% in 2024 with its highest post-Covid rate of 82%. The Office's partnership with the Ohio Attorney General for delinquent debt collection continues to be successful with over \$795,000 collected in 2024 and nearly \$5.5 million collected since 2016. With a lifetime debt resolution rate of 48%, the OAG's success rate significantly exceeds the industry standard of 20-30% for long-term delinquent debt.



COMMUNITY CONTROL SERVICES



Community Control: Defendants placed on Community Control are assessed with the ORAS tool. The Supervising Officer determines each probationer's risk of re-offending and then creates a case plan that addresses each probationer's unique needs and opportunities. In 2024, Community Control received 133 carry over supervision cases from 2023, accepted 232 new supervision cases, and completed 233 cases.

Diversion: The Stow Municipal Court offers two Diversion Programs for first time offenders with Theft and Underage Alcohol charges. The purpose of both programs is to educate and rehabilitate new offenders. Both programs require a \$300 entrance fee, completion of educational courses assigned by the Court, attendance at any court ordered substance abuse meetings, sixteen (16) hours of community service, submission to random drug screenings, completion of a three (3) page essay, and mandatory attendance at all diversion meetings. Participants may qualify for dismissal and sealing of their case upon successful completion of all program requirements. In 2024, Community Control received 61 carry over diversion cases from 2023, accepted 163 new diversion cases, and completed 178 cases.

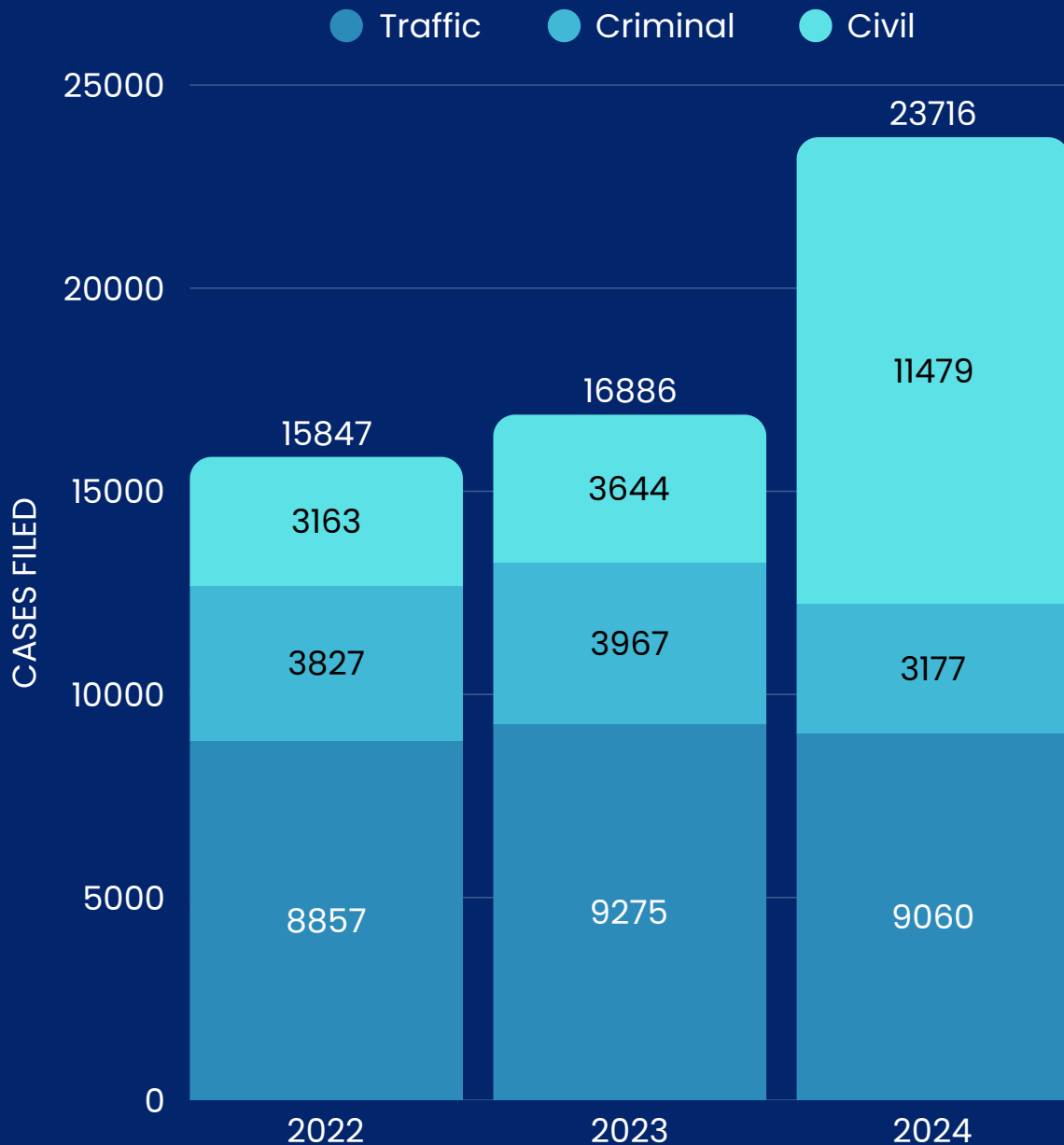
Sealings/Expungements Investigation: Officers perform investigations into a applicant's criminal history and other relevant factors to determine eligibility and make a recommendation to the Judge to grant or deny the applicant's request to seal or expunge their criminal case record. In 2024, Community Control received 12 carry over sealing investigations from 2023, accepted 133 new sealing / expungement applications, and processed 133 investigations to completion.

Electronic Monitoring (EM): Community Control monitors all Defendants placed on Secured Continuous Alcohol Monitoring Systems (SCRAM) and/or House Arrest by the Court as a condition of bond or sentencing. In 2024, Community Control continued 69 EM cases from 2023, accepted 346 new EM cases, and processed 370 EM cases to completion.

Monitoring: Community Control monitors offenders completion of any programming ordered by the Court as a condition of the offender's sentence (i.e. Driver Intervention Program (DIP), Multiple Offender Program (MOP), Anger Management, treatment/counseling programs). In 2024, Community Control continued to monitor the program participation of 69 offenders from 2023, monitored 85 new offenders, and closed 75 monitoring cases.

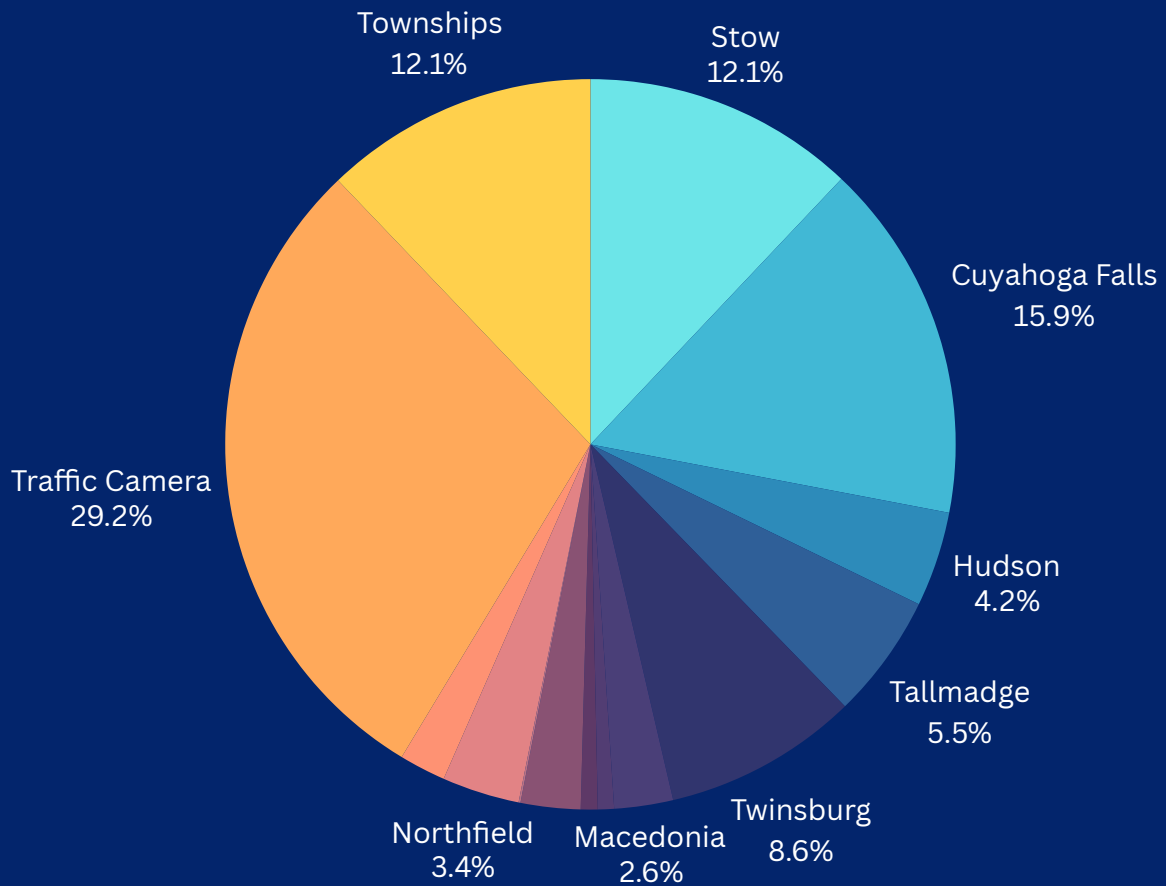
Presentence Investigation (PSI): Community Control Officers conduct detailed background and social history investigations of defendants found guilty of charged offenses to help the Judge determine an appropriate sentence. PSIs include review of the defendant's criminal history, family and social background, education and employment, financial situation, mental and physical health, substances use history, and the impact of the offense on the victim and the community. In 2024, Community Control carried over 6 PSIs, initiated 38 new PSIs, and completed 44.

CASELOAD ANALYSIS BY YEAR



Caseload trends over the past three years have shown a modest increase in traffic cases, but still several thousand less than pre-2020 traffic caseloads. Criminal cases went down significantly in 2024, likely as a result of marijuana legalization. The Court's civil caseload has continued to grow substantially in 2024 with 4,551 regular civil case filings and 6,928 civil traffic camera case filings.

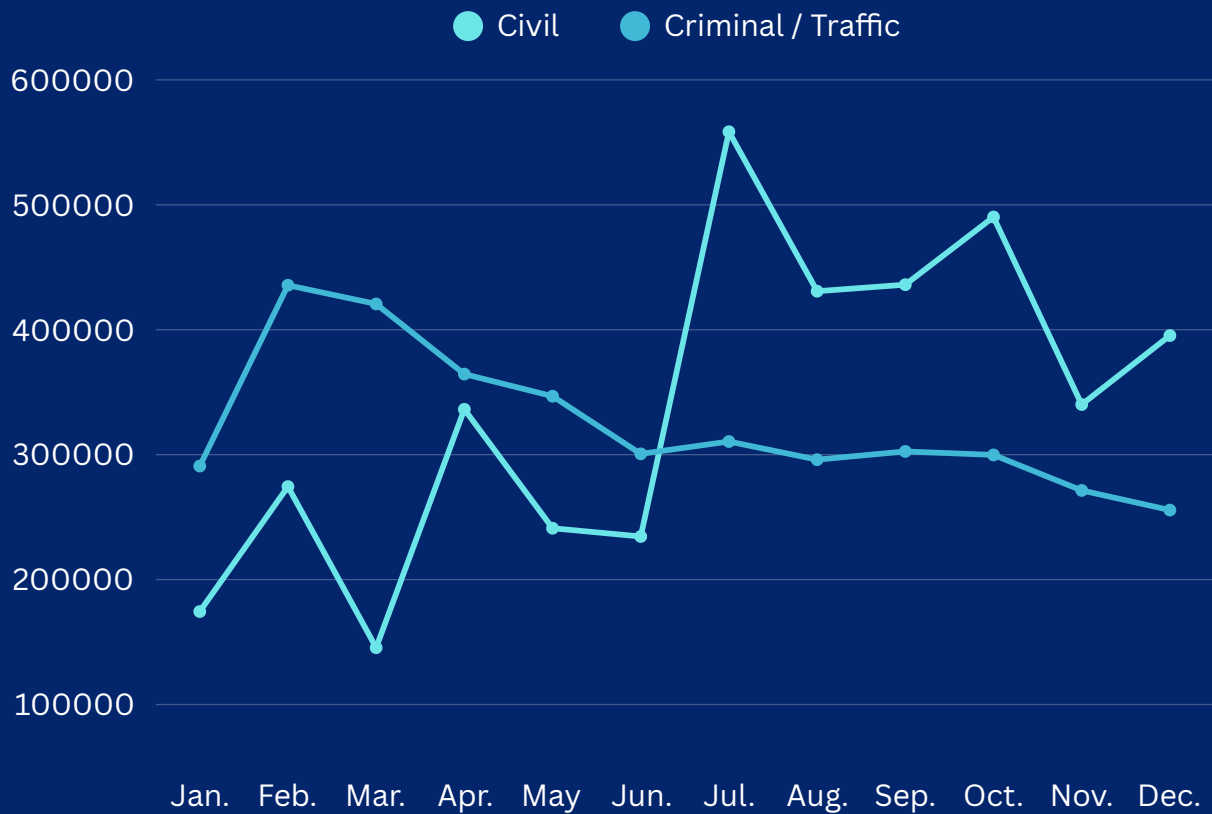
